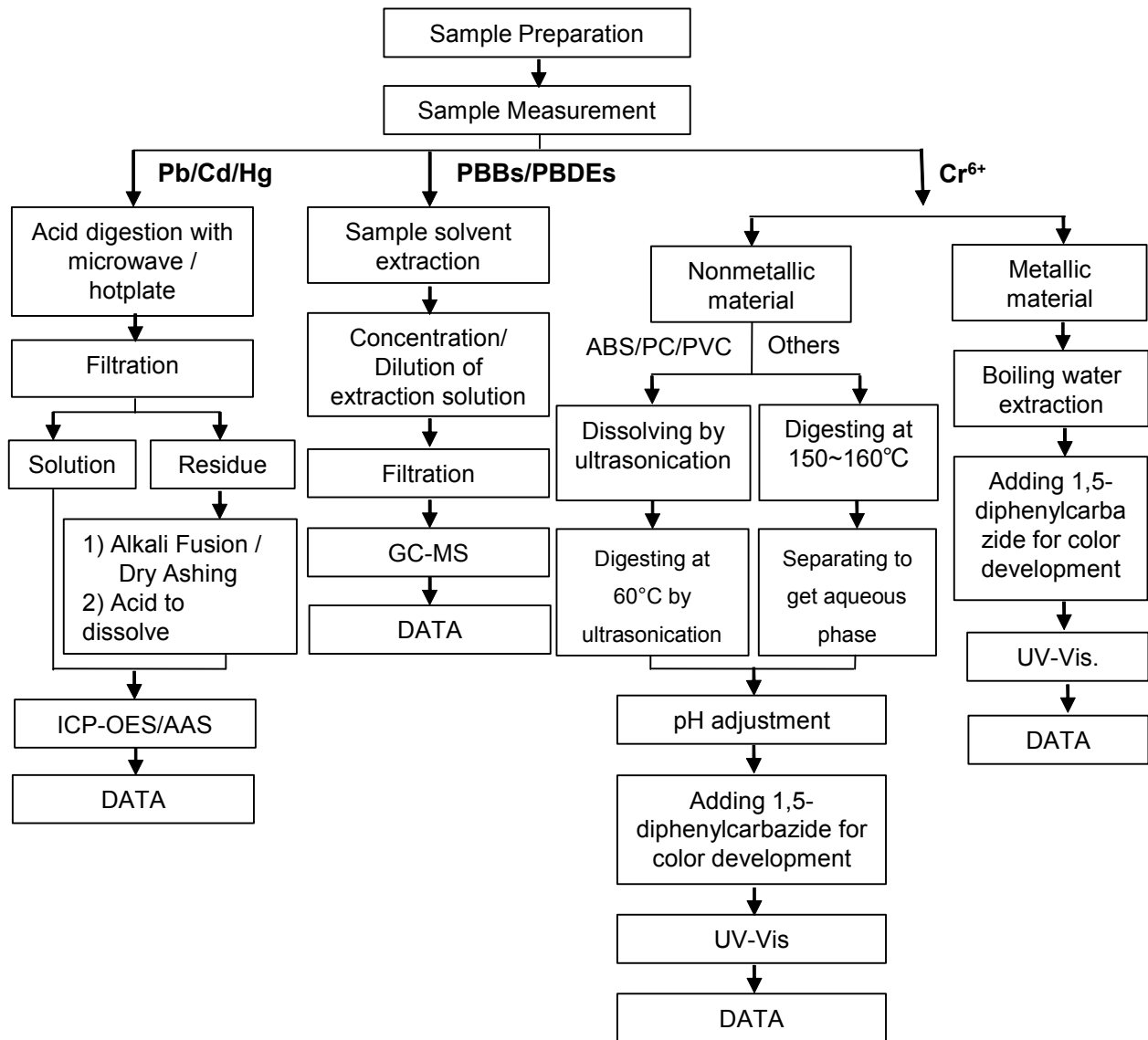

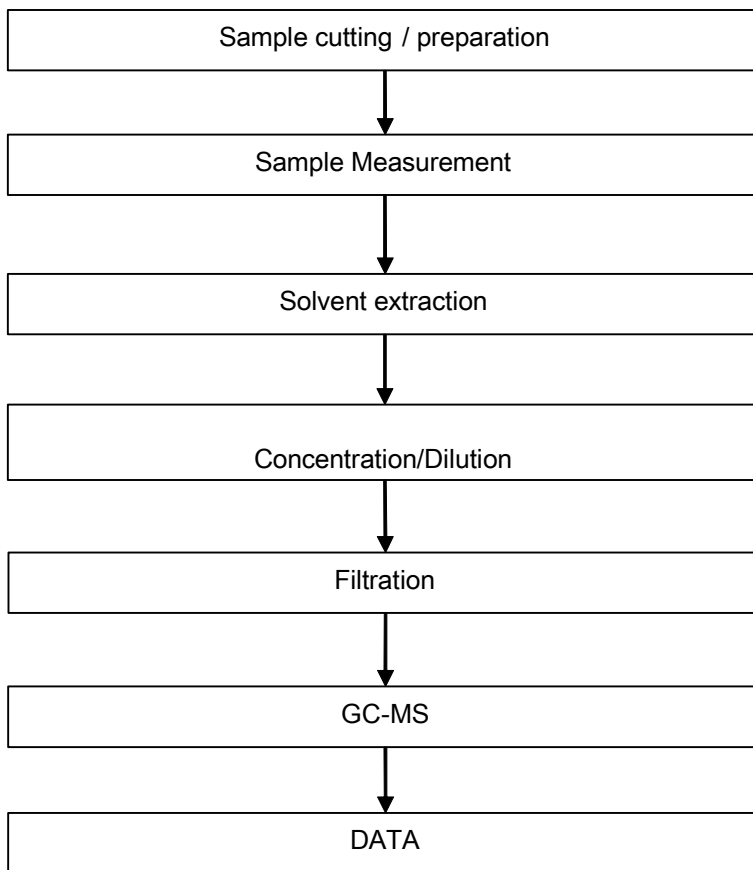

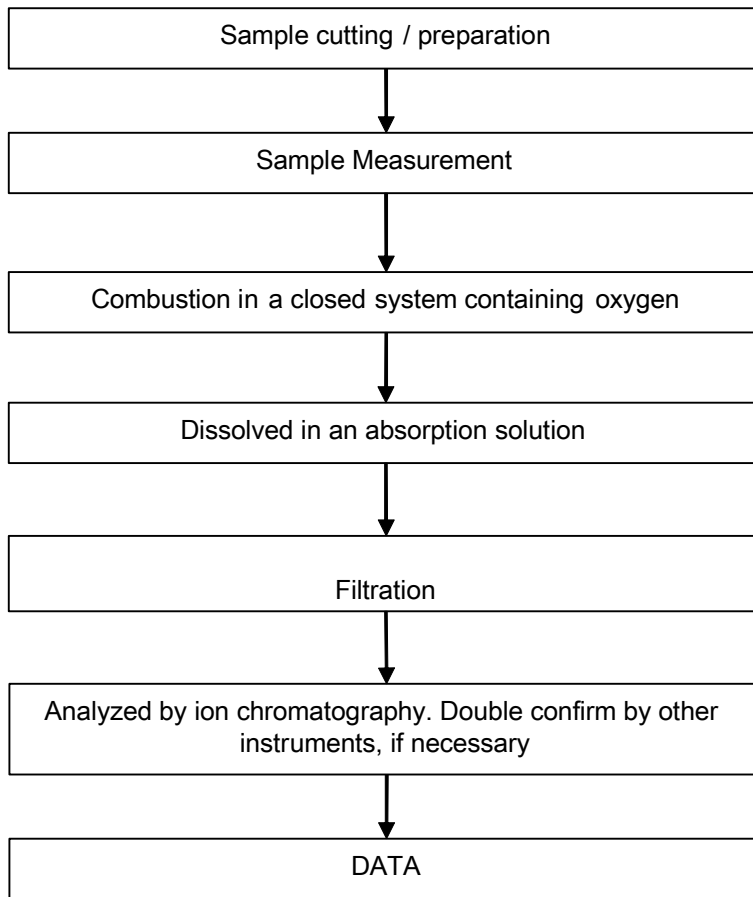

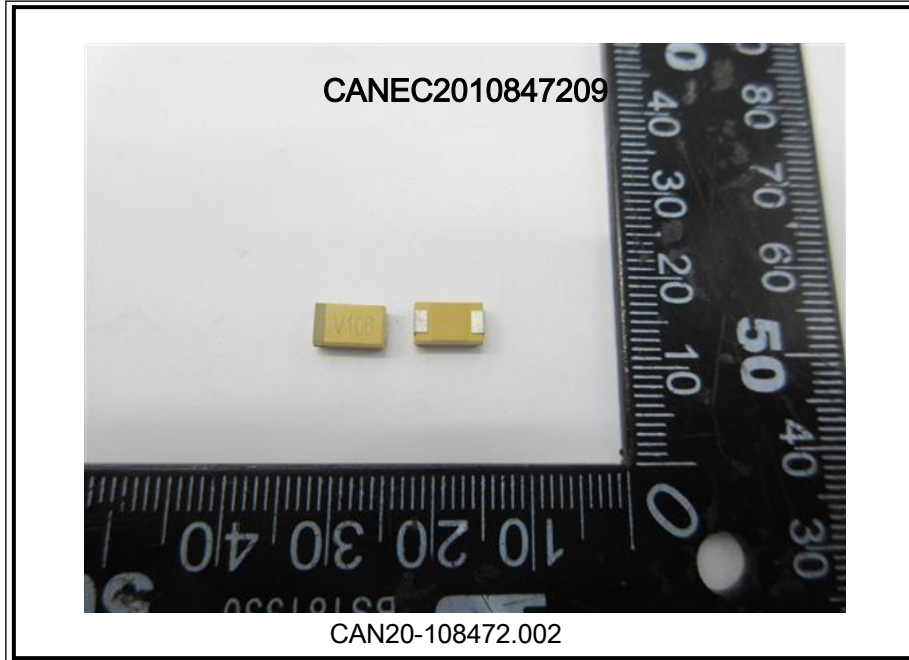
Halogen Testing Flow Chart
